ARTICLES OF INCORPORATION
OF

SAVIOR'S HOUSE FOR AT RISK CHILDREN, INC.
A NONPROFIT CORPORATION

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be:

SAVIOR'S HOUSE FOR AT RISK CHILDREN, INC.

The address of the principal office of this corporation shall be 236 Par Drive, Royal Palm Beach, Florida 33401, and the mailing address of the corporation shall be the same.

ARTICLE II.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to provide foster care.

ARTICLE III

The manner in which the directors are to be elected or appointed is as stated in the by-laws.

ARTICLE IV

ARTICLE V

This corporation is to exist perpetually.

ARTICLE VII




