ARTICLES OF INCORPORATION

OF

BETTER STREETS, INC.

The undersigned Incorporator, desiring to form a corporation not for profit under Chapter 617, Florida Statutes, as amended, hereby adopts the following Articles of Incorporation:

ARTICLE I DEFINITIONS

When used in these Articles, the following words shall have the following meanings:

- (a) "Articles" means and refers to these Articles of Incorporation.
- (b) "Association" means and refers to BETTER STREETS, INC., a Florida corporation not-for-profit.
- (c) "Board" means and refers to the Board of Directors of the Association.
- (d) "Bylaws" means and refers to the Bylaws of the Association.
- (e) "Common Expense" means and refers to the expense of operating the Association and of performing the duties and exercising the powers of the Association.
- (f) "Lot" means and refers to each residential building site included in the Property and any Dwelling located thereon or contained therein.
- (g) "Member" means and refers to each Member of the Association.
- (h) "Owner" means and refers to the record owner, whether one or more persons or entities, of fee simple title to any Lot in the Property, but excluding those having such interest merely as security for the performance of an obligation. All owners of a single Lot shall be treated for all purposes as a single Owner irrespective of whether such ownership is joint, in common, or tenancy by the entirety.
- (i) "Property" means and refers to the real property described on **Exhibit "A"** attached hereto.

ARTICLE II NAME

The name of the Association is: "Better Streets, Inc."

ARTICLE III PRINCIPAL OFFICE

The principal office of the Association is located at 12540 Park Avenue, Windermere, FL 34786.

ARTICLE IV REGISTERED AGENT AND OFFICE

Scott C. Brady, whose address is 12540 Park Avenue, Windermere, FL 34786 is hereby appointed the initial Registered Agent of the Association to accept service of process within the State of Florida at said address.

ARTICLE V PURPOSE AND POWERS OF THE ASSOCIATION

The Association does not contemplate pecuniary gain or profit to the Members thereof. The specific purpose for which the Association is formed is to improve the streets lying adjacent to the Lots, collect and disburse the money derived from assessments related to such improvements, and to exercise any and all powers, rights and privileges which a corporation organized under the non-profit corporation law of the State of Florida by law may now or hereafter have or exercise.

ARTICLE VI MEMBERSHIP

Each Owner of a Lot shall be a Member of the Association. The Association membership of each Owner shall be appurtenant to and inseparable from the Lot giving rise to such membership, and any transfer of title to a Lot shall operate automatically to transfer to the new Owner the membership in the Association appurtenant to that Lot.

ARTICLE VII VOTING RIGHTS

- (a) <u>Voting Rights</u>. Each Member shall have one (1) vote for each Lot owned by that Member.
- (b) <u>Multiple Owners</u>. Each vote in the Association must be cast as a single vote, and fractional votes shall not be allowed. When more than one person holds an interest in any Lot, the vote for such Lot shall be exercised as the owners thereof determine, but if joint or multiple Owners are unable to agree among themselves as to how their vote is to be cast, or if more than one (1) vote is cast for any Lot, none of the votes for that Lot shall be counted. If any Owner casts a vote on behalf of a Lot, it shall be conclusively presumed that Owner was acting with the authority and consent of all Owners of that Lot.

ARTICLE VIII BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board of five (5) directors. Each director must be a Member of the Association, or the designee of a corporate Member. The number of directors may be changed by amendment to the Bylaws.

The terms of the directors shall be concurrent. Any vacancy which shall occur in the Board of Directors prior to the expiration of the term of such class may be filled by the majority vote of the Members for the remainder of the full term. An increase in the number of directors shall be deemed to create vacancies for the purpose of this paragraph.

The method of nomination and election of the directors shall be stated in the Bylaws of the Association.

ARTICLE IX OFFICERS
