

I, ALAN TELISMAN, the undersigned, hereby execute these Articles of Incorporation for the purpose of becoming a not for profit corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, rights, privileges, immunities and liabilities of a not for profit corporation.

ARTICLE I

The name of the not for profit corporation is:

NEIGHBORS GIVING THANKS, INC.  
A NOT FOR PROFIT CORPORATION

ARTICLE II

The general nature of the business to be conducted shall be: a not for profit corporation.

The corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida, as a not for profit corporation, and more specifically is formed to gather funding for neighborhood initiatives. Specifically organized for charitable purposes.

ARTICLE III

This not for profit corporation shall have perpetual existence.

#### ARTICLE IV

The initial street address of the principal office of this not for profit corporation shall be 12219 South Dixie Highway, Miami FL 33156. The Board of Directors may, from time to time, designate such other post office address and place of the principal office of this not for profit corporation as it may see fit.

#### ARTICLE V

The number of Directors of this not for profit corporation shall be as provided by the By-laws, but shall not be less than Three (3). The manner in which the directors are elected is as stated in the bylaws.

#### ARTICLE VI

The names and addresses of each subscriber to these Articles of Incorporation of this not for profit corporation is as follows:

#### ARTICLE XI


