**WE**, the undersigned being desirous of forming a corporation for religious, charitable and philanthropic purposes, under Chapter 617 of the Florida Statutes, do hereby agree to the following:

**ARTICLE I**

**NAME:**

The name of this Corporation is **BAAL-PERAZIM MINISTRIES, INC.**

**ARTICLE II**

**PURPOSES:**

The nature and purpose of this corporation shall be:


## **ARTICLE X**
