OF

In order to form a corporation under and in accordance with the provisions of the laws of the State of Florida for the formation of corporations not for profit, the undersigned hereby associates itself into a corporation for the purposes and with the powers hereinafter mentioned; and to that end we do, by these Articles of Incorporation, set forth:

ARTICLE 1
NAME

The name of the not-for-profit corporation shall be **INLET HARBOR CHARTER BOAT ASSOCIATION, INC.** For convenience, the corporation shall be referred to in this instrument as **"CORPORATION"**.

ARTICLE 2
ADDRESS

The street address and mailing address of the **CORPORATION** is 133 Inlet Harbor Road, Ponce Inlet, Florida 32127.

ARTICLE 3
PURPOSE AND POWERS

The **CORPORATION** is created for the purpose of organizing and operating a charter boat association.

The **CORPORATION** shall have all powers as set forth in Section 617.0302, Florida Statutes 1999, and as subsequently amended.

**ARTICLE 4
DIRECTORS**

The directors of the **CORPORATION** shall be elected as established in the By-laws.

**ARTICLE 5
REGISTERED AGENT**

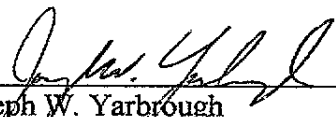
