**ARTICLE I. CORPORATE NAME**

The name of this corporation is: Fully Committed Holiness Church, Inc. (A Florida Corporation not for profit)

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation is: 147 Hickory Avenue, Crawfordville, FL 32327.

**ARTICLE III. PURPOSE**

The purpose of this corporation is for its members to congregate as a church and to perform all lawful functions of a Christian church, and to assist and help those in spiritual need. Individuals interested in the objectives and purposes of the association shall be eligible for membership. 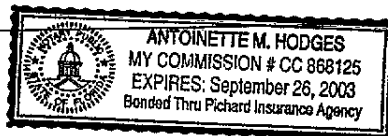


