Article 1-Name

The Name of this Corporation shall be called United Christian Outreach Ministries of Northeast Florida, Inc. Address will be 2220 Danson Street. Jacksonville, Florida 32209.

Article 2-Duration

This corporation shall exist on the date by which these Articles are filed.

Article 3- Purpose

The purpose for which this Corporation will exist is completely charitable, scientific, literary, and educational within the meaning of Section 501(C)(3) of The Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

This Corporation is non-profit and is organized for the purpose of providing care for the Spiritual needs as well as the psychosocial needs of persons inflicted with Aids and their significant others. The corporation will deal with the multi-faced Spectrum of the Aids disease which includes but is not limited to substance abuse, with the laws and Statutes of the State of Florida.
