**AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF**

**ARTICLE I**

The name of the corporation is:

The specific purpose for which this corporation is organized is:

A. To operate exclusively for such religious purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any future United States internal revenue law. This Corporation will be a church whose purpose is to minister to persons in the community, to provide worship services, charitable, benevolent, civic and spiritual purposes as a nonprofit corporation pursuant to the provisions of the Florida Not For Profit Corporation Act.

B. This Corporation will not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any future United States internal revenue law or (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or corresponding provisions of any future United States internal revenue law.

**ARTICLE IV**

The manner in which officers are elected or appointed is:

The officers will be elected as provided for in the Bylaws, and the directors shall not be personally liable for the debts of the Corporation.

Upon dissolution of the Corporation, the assets remaining after settling all just legal debts, demands, and liabilities of this Corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated

exclusively for charitable purposes which has established its tax exempt status under Section 5019c)(3) of the Internal Revenue Code.
