The undersigned incorporators for the purpose of forming a corporation under the Florida Not for Profit Corporation Act (*Fla. Stat. Chapter 617.0202*), hereby adopts the following Articles of Incorporation:

**ARTICLE I NAME OF THE CORPORATION**

The name of the corporation shall be: Second Byte Inc.

**ARTICLE II PRINCIPAL OFFICE & MAILING ADDRESS**

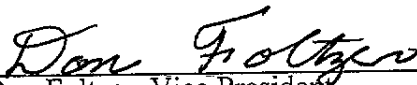
