

ARTICLES OF INCORPORATION OF DIVISION OF CORPORATION THE TRAILS OF TITUSVILLE HOMEOWNERS ASSOCIATION, INC. 00 APR 20 PM 2: 08

The undersigned, acting as incorporator of a corporation under the non-profit Corporation Act of the State of Florida, adopts the following articles of incorporation.

ARTICLE I - NAME

The name of the corporation is THE TRAILS OF TITUSVILLE HOMEOWNERS ASSOCIATION, INC.

ARTICLE II - DURATION

The corporation's duration shall be perpetual.

ARTICLE III - PURPOSES AND POWERS

The purposes for which the corporation is organized are:

- A. To operate The Trails of Titusville Homeowners Association and to undertake the performance of, and to carry out the acts and duties incident to the administration of The Trails of Titusville Homeowners Association in accordance with the terms, provisions, conditions, and authorizations contained in these Articles, the By-laws of The Trails of Titusville Homeowners Association, and the Declaration of Covenants, Conditions and Restrictions of The Trails of Titusville recorded among the public records of Brevard County, Florida;
- B. To carry out the duties and obligations given by the Declaration of Covenants, Conditions and Restrictions of The Trails of Titusville recorded among the public records of Brevard County, Florida; and
- C. To establish By-Laws and Rules and Regulations for the operation of The Trails of Titusville Homeowners Association and to provide for the formal administration of The Trails of Titusville Homeowners Association, and to enforce the Declaration of Covenants, Conditions and Restrictions of The Trails of Titusville recorded among the public records of Brevard County, Florida, and the By-laws of The Trails of Titusville Homeowners Association.

ARTICLE IV - MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated by the Declaration of Covenants, Conditions and Restrictions of The Trails of Titusville recorded

among the public records of Brevard County, Florida, and the Bylaws of The Trails of Titusville Homeowners Association.

ARTICLE V - REGISTERED OFFICE

The initial registered office of the corporation shall be at 235 South Maitland Avenue, Suite 216, Maitland, Florida 32751.

ARTICLE VI - REGISTERED AGENT

The initial registered agent, and his address is Berry J. Walker, Jr., 235 South Maitland Avenue, Suite 216, Maitland, Florida 32751.

ARTICLE VII - MINIMUM NUMBER OF DIRECTORS AND ELECTIONS

The initial board of directors shall consist of at least three members.

The names and addresses of the persons who shall serve as directors until the first annual meeting of members, or until their successors shall have been elected and qualified, are as follows:
