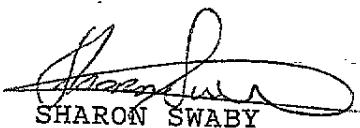

The undersign, acting as the incorporator of this corporation, hereby adopts the following Articles of the Incorporation as registered with the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be: HoUSE OF EMPOWERMENT, INC., hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPLE OFFICE AND MAILING ADDRESS

The address of the principle office and the mailing address of the Corporation is 9301 NW 19th Place, Sunrise, Florida 33322.

ARTICLE III: DURATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law, and shall have no stock.

ARTICLE IV: PURPOSES

The Corporation is organized and operated for the purpose of Waiver Support Coordination Services, Case Management/Social Work, and Human Related Services, and to transact any and all lawful business for which Corporations may be incorporated in this State as a non-profit corporation under F.S. 617.

ARTICLE V: BOARD OF DIRECTORS

The Board of Directors shall consists of (3) persons. The number of directors may be increased or decreased from time to time by amendment to the bylaws; however, there shall never be less than three directors. All directors shall be selected as provided for in the bylaws.

ARTICLE VI: REGISTERED OFFICE AND AGENT

The Corporation's registered office shall be located at 9301 NW 19th Place, Sunrise, Florida 33322. and SHARON SWABY, is the registered agent of the Corporation at that address.

ARTICLE VII: OFFICERS

The officers of the Corporation shall be a President, Vice President, Secretary, Treasurer, and such other officers as may be provided by the bylaws.

ARTICLE VIII: AMENDMENTS

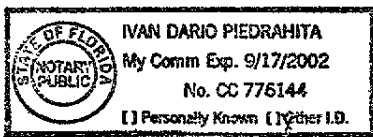
