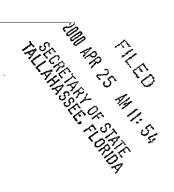

### ARTICLES OF INCORPORATION OF BEREANS IN GRACE FELLOWSHIP, INC A Non-Profit Corporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

### ARTICLE I

The name of the corporation shall be BEREANS IN GRACE FELLOWSHIP, INC.

# ARTICLE II

The principle place of business is 7572 Golf St. Keystone Hights Florida, 32656. The mailing address of the Corporation is 7572 Golf St. Keystone Heights Florida, 32656.

# ARTICLE III

The purpose for which the Corporation exists and its powers are as follows:

- A. To Govern
- This assembly shall have the right to govern itself and to conduct its own affairs according to the standard of the New Testament Scriptures. This right shall specifically include such matters as the calling of a pastor, the election of the church board, and the discipline of its members and the conducting of its own services and church program.
- To Acquire and Dispose In connection therewith, or incidental therto, this assembly shall have the right to purchase or acquire by gift, bequest or otherwise, either directly or as a trustee, and to own, hold in trust, use sel, convey, mortgage, lease, or otherwise dispose of any real estate or chattels as may be necessary for the furtheranc of its purposes and to exercise all other powers conferred upon it by its charter or by the aplicable nonprofit corporation laws of this state.
- To Worship, Fellowship, and Propagate The purpose of this assembly shall be to establish and maintain a place of worship of Almighty God, our Heavenly Father, to provide Christian fellowship for those of like faith, and to assume our share of responsibility and the privilege of porpagating the gospel of Jesus Christ by all available means, both at home and in foreign lands.

The manner in which the Directors of the Corporation are elected are as follows

A. The President of the Corporation shall be the Pastor of the assembly. He or she shall be elected by a two-thirds majority vote of all members of the church. Their term of office shall be for an indefinite period of time,

- B. The Secretary shall be elected by the church board from its members. The term of office shall be one year, and the secretary may serve consecutive terms without limitation.
- C. The Treasurer shall be elected by the church board from among its members. The term of office shall be one year, and the treasurer may serve consecutive terms without limitation.
- D. Directors, which constitute the church board, shall be elected by a majority vote of those active voting members present at time of election. They shall by elected to serve for a three year term, however, they may not serve more than two consecutive terms.
