We hereby submit the following as the original and complete set of articles of incorporation for a non-stock corporation under the provisions of Chapter 617.0202 of the Florida Statues and to that end set forth the following:

FIRST

The name of this corporation is:

Precision Contemporary Dance, Inc.

SECOND

Its principle office in the State of Florida is to be located at 3807 Sentry Drive (Temporary Location), in the City of Cocoa, County of Brevard.

THIRD

The purpose of the business and the objects proposed to be transacted, promoted and carried on are to do any and all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world.

This is a nonstock, nonprofit corporation. The purpose of the corporation is to engage in any lawful act or activity for which nonprofit corporations may be organized under the Non-Stock Corporation Law of Florida; and is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law), to conduct education, promotion, development and related activities on the art of dance.

Precision Contemporary Dance, Inc. is an organization dedicated to the development, education and promotion of the art of dance. Through the performance group, children and adults will have the opportunity to develop, educate and promote a diversity of dance art forms. Education and promotion of a diversity of dance art forms, including but not limited to, ballet, jazz, tap, hip-hop and modern will be accomplished through educational flyers, newsletters, performances and a web site. Original and classical productions developing and promoting the art of dance in the community will be accomplished through public performances at Libraries, Schools, Hospitals, and Nursing homes as well as full-length productions at a theater. Community outreach programs, such as scholarships and a dance therapy program will be established to work with the underprivileged and disabled. Precision Contemporary Dance, Inc.'s goal is to share the love of dance through development, education and promotion with our community as well as assisting talented and motivated dancers have an opportunity to realize their potential and also their dreams.

In fulfillment and furtherance of the social and educational objectives outlined above, the corporation shall seek to provide funds, such as are necessary to engage the personnel, resources and facilities required to carry out the task, primarily by funding from governmental units, grants, memberships, and contributions from the general public, or from a combination thereof.

The foregoing procedures and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any lawful non-profit purposes or activities which may become necessary or desirable for the furtherance of the corporate objectives heretofore expressed above.

FOURTH

A Board of Directors shall manage the activities and affairs of the corporation. The number of directors, which shall constitute the whole board, shall be such as from time to time shall be fixed by, or in the manner provided in, the bylaws, but in no case shall the number be less than three. The directors need not be members of the corporation unless so required by the bylaws or by statute. The Board of Directors shall be appointed on an annual basis, or as established by the The Founders (Kathleen Clark and Margaret Goudy) will appoint the Board of Directors. In the event the founders are unable to appoint the Board of Directors due to death or disability; the directors shall be elected by a majority vote of the current directors. The initial board may continue with those whom it elects at the annual meeting of the corporation to be held on such a date as the bylaws may provide, and hold office with subsequent boards. The bylaws shall specify the number of directors necessary to constitute a quorum. The directors of the corporation may, if the bylaws so provide, be classified as to term of office. The corporation may elect such officers as the bylaws may specify, subject to the provisions of the statute, who shall have titles and exercise such duties, as the bylaws may provide. The Board of Directors is expressly authorized to make, alter, or repeal the bylaws of this corporation. This corporation may in its bylaws confer powers upon its Board of Directors in addition to the foregoing, and in addition to the powers and authorities expressly conferred upon them by statute. This is true, provided that the Board of Directors shall not exercise any power of authority conferred herein or by statute upon the members.

FIFTH

The initial number of directors to constitute the Board of Directors shall be three [3], and shall be further designated as determined by the bylaws of the corporation. The names and mailing addresses of the persons who are to serve as the initial directors are as follows:

The corporation shall not have any capital stock and the conditions of membership shall be stated in the bylaws.
