ARTICLE OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be: Christian Women Interdenominational Ministries, Inc. This is a not for profit organization.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall initially be located at 6250 College Blvd., Pensacola, FL 32504 for meeting only. The mailing address shall be P O Box 1564, Pensacola, FL 32597.

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation are:

- Religion:** To bring all denominations together to foster unity for one through love, respect and fellowship.
- Social:** To address health, social and economic concerns affecting the community.
To provide assurance and assistance to HIV Positive and Aids Victims.
To arrange training for low-income workers and poverty stricken families.
To seek solutions for illiteracy, juvenile delinquency, rising crime and other social inadequacies.
- Economics:** To develop training programs for the community to provide better paying jobs.
To assist minorities, especially women, in acquiring business ownership, decent housing and investment opportunities
- Political:** To become more involved in the political process through education and voter registration.
To research, lobby and address issues involving the community.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The Human Resource Committee shall nominate officers from the Board of Directors or from the special committee or the existing committee. Each nominee shall have served on the Board of Directors or the existing for a minimum of one year.

Each nominee must possess the skills, time, willingness and such other qualifications as may be required in the pursuit of the duties of the office for which the nomination of the person is being considered.

The names of nominees shall be submitted to the Board of Directors prior to its annual meeting in October and voted on by a majority of members present.

The term of office for all elected officers shall be for 2 year period, running from January to January. An officer may be re-elected for a third term but may not serve for more than three consecutive terms in the same office.

The Board of Directors is empowered to waive this latter provision upon an affirmative vote of two-thirds of those members present at a meeting of the Board.
