The undersigned incorporators, in order to form a non-profit corporation under the laws of the state of Florida, adopt the following Articles of Incorporation:

THREE: This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law primarily for religious purposes.

More specifically, the purpose of this Fellowship is to fulfill The Great commission given by our Lord, Jesus Christ, by promoting His Gospel, by teaching and preaching The Word of God by any and all means, and in all places, consistent with the Articles of Incorporation of this Fellowship. It is our purpose to propagate the true knowledge of the Christian Religion;

To spread the knowledge of The Gospel of Jesus Christ to and through its ministers, assemblies, churches, missions and to all persons who may be reached through its efforts to the end that all may have the blessings derived from the knowledge of the faith of Jesus Christ;

To encourage ministers who have the call of God on their heart to minister the Gospel of Jesus Christ to the world and to assist them by fellowship, prayer and cooperation consistent with the Christian service;

To educate men and women for the general ministry of God's Word. In furtherance of this, to own, develop, establish and operate schools, colleges or other institutions for the purpose of training, preparing and educating people for the purpose of human service and teaching and preaching the Word of God, as revealed in the Holy Bible;

To establish and operate churches and prayer groups anywhere in the world.

To ordain, license or otherwise commission ministers for the work of the ministry, and to credential them, according to their particular need, for their calling in the general work of the ministry of the Gospel and the general purpose of the church;

To hold in the minds of its members due regard for the laws of the land and the duties they owe to God and to mankind in general, both temporal and spiritual;

To buy, lease, own, possess and sell or manage such properties, both personal and real and to accept or manage any endowments or gifts as may become necessary through its members or anyone who may become interested in our purpose;

To accept funds, such as free-will offerings, donations, tithes, membership fees, endowments or any other legitimate manner of transference of property, both personal and real, in common usage in religious realms. These moneys, funds or endowments shall be used for the purposes above set forth and hereinafter provided by the Executive Board of Directors;

To do any and all things deemed by the Executive Board of Directors to be necessary or proper in the developing or carrying out the general work and purposes of this Corporation.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

SIX: The period of duration of this corporation is perpetual

SEVEN: The classes, rights, privileges, qualifications and obligations of members of this corporation are as stated in the Bylaws of this corporation.

EIGHT: Any additional provisions for the operation of the corporation are as follows:

The property of this corporation is irrevocably dedicated to religious purposes, and no part of the net income or assets of this organization shall ever inure to the benefit of a director or officer of the corporation, or to the benefit of any private individual.


Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation organized and operated exclusively for religious purposes and that has established its tax-exempt status under 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.


Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
