**Articles of Incorporation
In Compliance with Chapter 617, F.s., (Not for Profit)**

Article I Name

**The name of the corporation shall be:
Abel Community Kitchen School, Inc.**

Article II Principal Office

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
