**ARTICLES OF INCORPORATION

**ARTICLE THREE**

The purpose for which the corporation is organized, and the powers which the corporation shall have, shall include the following:

1. The corporation is organized exclusively for social, leisure and hunting purposes.
2. The primary purpose of the corporation shall be to lease, manage, maintain, operate, supervise and to otherwise deal with properties of any kind or nature wherever located so as to encourage, stimulate, foster and promote hunting and other outdoor sports on behalf of its members; to generally provide for the conveniences and leisure activities of its members and provide facilities where they may engage in hunting and other outdoor sports and to promote and encourage conservation of natural resources and wildlife.
3. The corporation is authorized to lease, exchange, receive by donation or otherwise acquire interests in land, to purchase, construct, exchange, receive or otherwise acquire or place improvement thereon and to manage and operate all of said facilities for the use, benefit and convenience of its members and their guests, provided, however, that substantially all the work in carrying on such activities shall be performed for the corporation without compensation.

#### ARTICLE FOUR

The officers of the corporation shall consist of a president, vice president, a secretary-treasurer, all of whom are elected by the members of the corporation.  
The Manner in which the Directors are elected is as stated in the bylaws.
