ARTICLE I

THE NAME AND ADDRESS

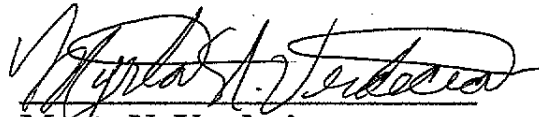
