**ARTICLES OF INCORPORATION
FOR

The undersigned, for the purpose of forming a Florida corporation pursuant to Chapter 617 of the Florida Statutes (Not for Profit), hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The names of this corporation shall be:

ARTICLE II. PRINCIPAL OFFICE

The purpose of this not-for-profit corporation is to operate a Church.

ARTICLE V. ORIGINAL BOARD OF DIRECTORS AND MANNER OF ELECTION

Section 1. Management by Directors. The property, business and affairs of the church shall be managed by a board of directors, which shall consist of not less than three persons but as many persons as the board of directors shall from time to time determine.

Section 2. Original Board of Directors. The names and addresses of the first board of Directors of the church, who shall hold office until the first annual meeting of members and thereafter until qualified successors are duly elected and have taken office, shall be as follows:

Section 3. Election of Members of Board of Directors. Except as otherwise provided herein and for the first board of directors and their replacements, directors shall be elected by a plurality vote of the members of the church at the annual meeting of the membership as provided by the by-laws.

Section 4. Duration of Office. Members elected to the board of directors shall hold office until the next succeeding annual meeting of members and thereafter until qualified successors are duly elected and have taken office.

Section 5. Vacancies. If a director elected by the general membership shall for any reason cease to be a director, the remaining directors so elected may elect a successor to fill the vacancy for the balance of the term.

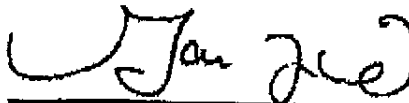
