ARTICLE I
CORPORATION NAME

The name of this Corporation shall be: GULF COAST CHRYSALIS, INC., A Nonprofit Corporation. NO STOCK BASIS.

ARTICLE II
PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III
NATURE OF BUSINESS AND POWERS

To provide a religious weekend experience for the youth of the community and engage in any and all business permitted under the laws of the State of Florida.

ARTICLE IV
