# Articles of Amendment to Articles of Incorporation of Fred Lang Foundation, Inc.

These Articles of Amendment are made to the Articles of Incorporation of FRED LANG FOUNDATION, INC., a Florida not-for-profit corporation, pursuant to the provisions of Section 617.1006 of the Florida Statutes as follows;

- 1. The name of the corporation is: FRED LANG FOUNDATION, INC.
- 2. Article VI of the Articles of Incorporation is amended to read as follows (words deleted are stricken through with hyphens and words added are underlined):

# **ARTICLE VI - MEMBERS**

This corporation is organized upon a non-stock basis.

There shall be various classes of Members of this corporation. The only voting Members shall be Members of its Board of Directors. Other classes of Members, which shall not have voting rights shall be determined from time to time by the Board of Directors. The sole class of members of this corporation shall be its Board of Trustees. The qualification for members/trustees Directors and the manner of their admission shall be regulated by the Bylaws.

The Members of this corporation shall have no right, title, or interest whatsoever in its income, property, or assets, nor shall any portion of such income, property, or assets be distributed to any Member on the dissolution or winding-up of this corporation. Members of this corporation shall not be personally liable for the debts, liabilities, or obligations of the corporation, and shall not be subject to any assessments.

3. Article VIII of the Article of Incorporation is amended to read as follows (words deleted are stricken through with hyphens and words added are underlined):

# **ARTICLE VIII - TRUSTEES DIRECTORS**

The powers of this corporation shall be exercised, its property controlled, and its affairs conducted by its Board of Trustees Directors. The number of Trustees Directors shall initially be three (3); provided, however, that such number may be increased as provided by the Bylaws, but shall not be greater than nine (9) twenty-five (25) Members nor less a than three (3).
