ARTICLES OF INCORPORATION

OF

PARENT EDUCATION CENTER, INC.

OO MAN ED AND SO I, the undersigned, do hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of establishing a not for profit corporation, under the provisions of Chapter 617, Laws of Florida and section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE I

The name of this corporation will be Parent Education Center, Inc.

ARTICLE II

The general purpose for which this corporation is established is: To provide a free, comfortable environment for parents of children with communications and learning challenges, where they have the opportunity to be exposed to the many tools available to them, which facilitate emotionally healthy, stimulating, and positive environments for children with these challenges.

Parents are often at a loss as to how to help their children and themselves when their child has been confronted with the presence of communications or learning challenges. Children with such challenges derive great benefit when their parents are better informed and supported with tools to cope with realities facing their children and families. Ultimately, this could lead to a better quality of life for the child, the parents and the family dynamic. In the past twenty years, this country has experienced an almost ten-fold increase in the number of children identified with complex, non-progressive developmental disorders, which fit the concept of communications and learning challenges. These challenges have been, unfortunately, commonly labeled as:

- Attention Deficit Hyperactivity Disorder (ADHD), Attention Deficit Disorder (ADD)
- Autistic Spectrum Disorder (ASD), Autism, Asperger's Syndrome
- Pervasive Developmental Disorder (PDD), Multi-Systems Disorder (MSD)
- Dyslexia, Specific Learning Disabilities (SLD)
- Central Auditory Processing Disorder (CAPD)
- Sensory Processing Deficits
- Sensory Integration Disorder (SID)
- Apraxia, Dyspraxia and Motor Planning Dysfunction.

All of these disorders involve limitations or deficits in many of the same areas of developmental functioning, such as:

Language

- Motor planning (sequencing of actions or behaviors)
- Social interactions and social relatedness
- Cognition perceptual functioning (visual, auditory and kinesthetic)

The Parent Education Center is based on the following principles:

- 1. Non-labeling/non-syndrome oriented approach
- 2. Functional Development Approach
- 3. The BOLD Approach

ARTICLE III

The corporation is to have perpetual existence.

ARTICLE IV

Said corporation is organized exclusively for charitable, educational and scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE V

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing of distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE VI

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

ARTICLE VII

The street address of the initial registered office of the corporation and the principal office of the corporation is 7000 W. Palmetto Park Road, Suite #108, Boca Raton, Florida 33433 and the name of its initial registered agent at such address is DEBORAH P. COYNE.

ARTICLE VIII

The manner in which the Board of Directors are to be elected or appointed shall be stated in the By-Laws.

ARTICLE IX

The By-Laws of the corporation are to be made, altered or rescinded by members of the Board of Directors.

ARTICLE X

Amendments to the Articles of Incorporation may be proposed by any member of the Board of Directors and adopted by a majority vote of the Board of Directors present at a meeting called for that purpose.
