FIRST: ARTICLE II – PURPOSE & PREROGATIVES (AMENDED)

To Perpetuate, promulgate, and support the doctrines of the General Council of the Assemblies of God, and it, and all its property, both real and personal, shall be subject to the laws, usages and ministerial appointments of the General Council of the Assemblies of God, Springfield, Missouri, and the Florida Multicultural District Council of the Assemblies of God, Inc., as are now or shall be from time to time established, made, and declared by the lawful authority of said Councils.

SECOND: ARTICLE X – DISSOLUTION (ADDED)

In the event this corporation shall cease to function for the purposes herein set forth, then all property, real or chattel, shall revert to the Florida Multicultural District Council of the Assemblies of God, Inc., under whose supervision this church functions, or to the parent body, the General Council of the Assemblies of God, a Missouri Corporation with headquarters at Springfield, Missouri. The Florida Multicultural District Council of the Assemblies of God, inc. and/or the General council shall have full authority to sell such property and to use the proceeds derived there from for the extension of the work of the Assemblies of God specially those churches that is corporation may have established as daughter churches.

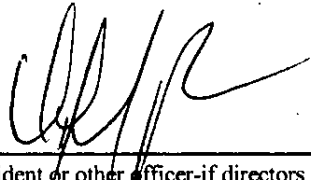
