ARTICLE I - NAME

The name of this corporation shall be The Islamic Development Group, Inc.

ARTICLE II - INITIAL OFFICE AND MAILING ADDRESS

The Initial principal office shall be 607 E. Williams Street, Melbourne, FL 32901. The Initial mailing address shall be P.O. Box 1924, Melbourne, FL 32901

ARTICLE III - PURPOSE

The purpose(s) for which this corporation is organized are:

1. To ensure the establishment of the religion of Al-Islam throughout the state of Florida, as it is promulgated by the Holy Quran and demonstrated by the life of Prophet Muhammad, (S.A.W.).
2. To encourage the development of elementary and secondary educational systems in accord and pursuant to the State parochial school guidelines and Quran and Sunnah.
3. To inspire the spirit of economic growth and strength in the State of Florida and to enhance the security and longevity of the Islamic communities.

6. Upon dissolution of this corporation all properties and assets of this corporation after payment of debts will belong to the Muslim American Society Shura.

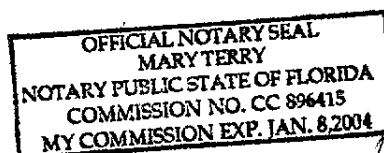
