The undersigned Incorporator, for the purpose of forming a Corporation under Florida Statutes Chapters 607 and 621, as amended, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME AND PRINCIPAL OFFICE

The Corporation will exist perpetually, commencing with the filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE III: PURPOSE

The specific purpose(s) of the corporation is to: Our mission is as follows: To provide assistance in training, education, and charitable services for the public and its membership as to the need of the people with HIV/AIDS and/or emotional problems associated with this disease.

Goal/Objective is to support African Americans, and African American women of childbearing age.

In order to reach our goal and support our target populations, we seek to achieve the following objectives:

- To educate the community at large about HIV/AIDS issues, and increase community awareness of this disease.
- To support the current treatment available for HIV/AIDS and the development of planning to decrease the transmission of HIV/AIDS.
- To encourage the target population to get medical care at an early stage----not when it's a full-blown AIDS infection.

- To seek improvement in the HIV/AIDS health care system locally, statewide and nationally.
- To strive to reduce the discrimination and stigma attached to persons labeled with the HIV/AIDS illness.
- To provide a support system for individuals and the infected/affected community to come together and discuss issues and concerns related to African Americans.

ARTICLE IV: DIRECTORS AND MEMBERS
