**ARTICLES OF INCORPORATION, A NON-PROFIT INCORPORATION OF
THE JONAS HOUSE OF LOVE, INC.**

ARTICLE I

The name of the corporation shall be The Jonas House of Love, Inc.
This corporation is organized pursuant to the FLORIDA Non-
Profit Corporation Codes.

ARTICLE II

The principle place of business and mailing address of this

ARTICLE III

To provide assistance for homeless families, assisting families with referrals to appropriate
agencies to become self sufficient.

ARTICLE IV

The manner in which the directors are elected or appointed is as follows: The Board of
Directors will serve a one year term. Each director shall hold office authority to appoint
other staff personnel as needed. In the event that an official position is vacated, the Board
shall appoint a temporary replacement for the position until an election can be conducted.



follows: the property of this corporation irrevocably decicated to Charitable purposes and no part of the net income or assetsof the organization shall ever ensure to the benefit of any director, officer or member thereof or the benefit of any private person. On disssolution of the corporation, its assets remaining after payment of,or provision for payment of all debts,and liabilities of the corporation, shall be distributed to nonprofit fund foundation, or corporation, which is organized and operated exclusively for Charitable Programs under Section 501(c) (3)of the Internal Revenue Services Code. The duration of this shall be perpetual, no stock and shall have no members.This corporation is organized and operated exclusively for Charitable purposes within the meaning of Section (501) (c) (3) of the Internal Revenue Code. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activity not permitted (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code;(2) by a corporationcontribution'to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
