# ARTICLES OF INCORPORATION, A NON-PROFIT INCORPORATION OF THE JONAS HOUSE OF LOVE, INC.

# ARTICLE I

The name of the corporation shall be The Jonas House of Love, Inc. This corporation is organized pursuant to the FLORIDA Non-Profit Corporation Codes.
