ARTICLES OF INCORPORATION

OF

SUNCOAST HEALTH AND EDUCATION FOUNDATION, INC.

In compliance with the requirements of Florida Statutes 617, the undersigned, all of whom are residents of Pasco County, Florida, and all of whom are of full age, have this day voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

ARTICLE I.

The name of the corporation is Suncoast Health and Education Foundation, Inc., hereinafter called the "Foundation".

ARTICLE II.

The principal office of the Foundation is located at 14000 Fivay Road, Hudson, FL 34667.

ARTICLE III.

Christopher R. Hyers, whose address is 1872 Kinsmere Drive, New Port Richey, FL 34655 is hereby appointed the initial registered agent of this Foundation.

ARTICLE IV.

This Foundation does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are to provide and exercise any and all powers, rights and privileges which a corporation organized under the non-profit corporation law of the State of Florida by law may now or hereafter have or exercise, including but not limited to providing health related education, improving access to health care and improving quality of care.

This Foundation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the Foundation shall inure to the benefit of any director, officer of the Foundation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Foundation) and no officer of the Foundation or any private individual shall be entitled to share in the distribution of any of the Foundation assets on dissolution of the Foundation.

No substantial part of the activities of the Foundation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501 (h) of the Code), or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the Foundation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a Foundation whose contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

Upon the dissolution of this Foundation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future tax code), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the Foundation is then located, exclusively for such purposes or to such Foundation or Foundations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE V.

The affairs of this Foundation shall be managed by a Board of eleven (11) Directors who need not be members of the Foundation. The number of Directors may be changed by amendment of the By-Laws of the Foundation. The names and addresses of the persons who are to act in the capacity of Directors until the selection of their successors are:

ARTICLE VI.

The affairs of this Foundation shall be administered by a President, Vice-President, Secretary and Treasurer, who need not be members of the Foundation. The following persons shall act in the

ARTICLE VII.

The name and address of the subscriber to these Articles of Incorporation for the Foundation is Christopher R. Hyers, 1872 Kinsmere Drive, New Port Richey, FL 34655.

ARTICLE VIII.

The By-Laws of the Foundation will be adopted by a two-thirds (2/3) majority of the Board of Directors and the members of the Foundation.

ARTICLE IX.

The Foundation may be dissolved with the assent given in writing and signed by not less than two-thirds (2/3) of the members of the Foundation. Upon dissolution of the Foundation other than incident to a merger or consolidation, the assets of the Foundation shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Foundation was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any nonprofit corporation, Foundation, trust or other organization to be devoted to such similar purposes.

ARTICLE X.

The corporation shall exist perpetually.

ARTICLE XI.

Amendment of these Articles shall require the assent of seventy-five (75%) percent of the entire membership.
