ARTICLES OF INCORPORATION OF DUE DROP INN COMPANY, INC. (a Florida not-for-profit corporation)



The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE_I

Name 1

The name of the Corporation shall be DUE DROP INN COMPANY, INC..

ARTICLE II

Principal Office
