ARTICLES OF INCORPORATION

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I: The name of this organization shall be known as: THE ORLANDO BROTHERHOOD OF POLICE OFFICERS INC.

ARTICLE II: The principal place of business and mailing address is:

Orlando, FL. 32801

ARTICLE III: The purpose of the organization is to secure all legitimate rights and privileges for the Orlando Police Officers and Community Service Officers; and the Orlando Community; to evaluate the policies and programs within the Criminal Justice System and their effect upon the community; to establish the free and rapid flow of pertinent information and educational opportunities that are available to all members and the community; to elevate, protect, and work for the good and welfare of the community, the country, and the membership; and to encourage and aid the enlistment of highly qualified and motivated citizens to the law enforcement profession.

ARTICLE IV. Directors / Officers: The election of directors will be as stated in the bylaws. The Officers of the Corporation shall include a President, the Vice President, Secretary, Chaplain, Treasurer, Sergeant At Arms. Other officers, s may from time to time be appointed by the President, or pursuant to a delegation of power in accordance with the provisions thereof. Such Officers shall have the authority to perform the duties prescribed by the President and the Executive Board. The elected officers shall be the aforementioned officers. Election of Officers shall be held annually. Each elected officer shall assume office by the second (2nd) Thursday in October of each year after the election which shall be held by the second (2nd) Thursday of September of the previous year. Each Officer shall hold office until his/her successor is elected and shall

be created and filled at any meeting of the Executive Board.

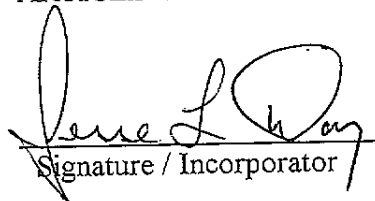
