

**Amendments to the Articles of Incorporation of The New Lackawanna Athletic Association Inc.**


**We the Board Of Directors does herby unanimously vote to adopt the following amendments to our Articles of Incorporation.**

**Add the following three paragraphs:**

- 1.) The purpose for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501© (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- 2.) Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by organized exempt from Federal income tax under section 501© (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- 3.) Upon the dissolution of the organization, assets shall be distributed for ~~or~~ or more exempt purpose within the meaning of section 501© (3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the Federal, State, or Local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of organization is then ~~located~~, exclusively for such purposes.
