## Add the following three paragraphs:

- 2.) Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by organized exempt from Federal income tax under section 501© (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- or more exempt purpose within the meaning of section 501© (3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the Federal, State, or Local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of organization is then located, exclusively for such purposes.
