**ARTICLES OF INCORPORATION
OF

(a Florida Not-For-Profit Corporation)

Pursuant to Chapter 617, Florida Statutes (Not for Profit), these Articles of Incorporation are created by undersigned, as the sole incorporator, for the purposes set forth below.

ARTICLE I


ARTICLE VI
