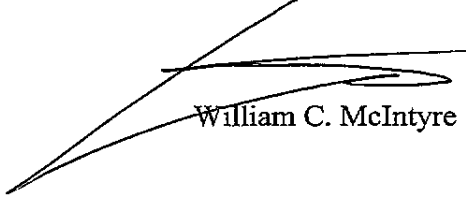

I, the undersigned incorporator of this Corporation, hereby make, execute and acknowledge these Articles of Incorporation under the Florida Not for Profit Corporation Act, for the purpose of forming a corporation under the laws of the State of Florida.

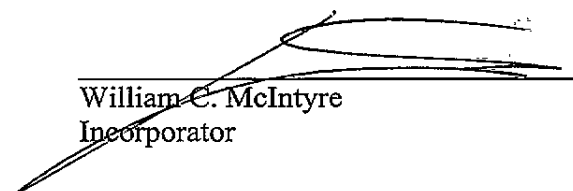

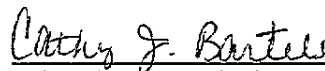

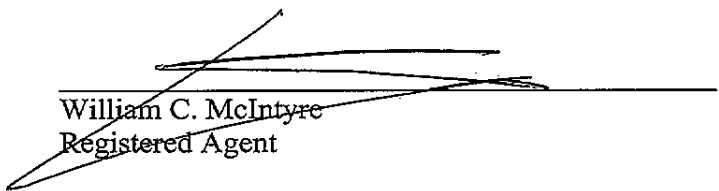
