EXHIBIT "A"

JASON'S ANGELS CHARITABLE FOUNDATION, INC.

PLAN OF DISTRIBUTION OF ASSETS

Pursuant to section 617.1406 of the Florida Statutes, the Corporation's assets shall be distributed as follows:

1. \$10,000.00 to P.A.N. (Proyecto Ayuda al Nino) EIN 59-1759029;
2. \$10,000.00 to Unike Support Services, EIN 65-0777337;
3. \$5,000.00 to HAFA (Hispanic America Fighters' Association); and
4. The balance of the Corporation's assets to the Jackson Memorial Foundation c/o the International Kids' Fund (Reg. # NO CH 3178).

Prior to these distributions, the officers of the Corporation shall make certain that all liabilities and obligations of the Corporation shall be paid and discharged.

A copy of this plan of distribution of assets, authenticated by an officer of the Corporation and containing the officer's certificate of compliance with the requirements of subsection (2) of section 617.1406 shall be filed with the Secretary of State.
