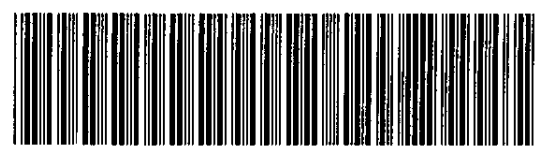

ARTICLE 15 DISPOSITION OF ASSETS IN THE EVENT OF DISSOLUTION


