ARTICLES OF INCORPORATION
OF
FLORIDA SUNCOAST PUPPET GUILD, INC.

We, the undersigned, hereby associate ourselves for the purpose of forming a Florida Corporation not-for profit pursuant to Chapter 617.0202 of Florida Statutes.

ARTICLE I: The name of the corporation shall be FLORIDA SUNCOAST PUPPET GUILD, INC.

ARTICLE II: The principal office is 7107 N. Howard Ave. Tampa, FL 33604-5260

ARTICLE III: PURPOSE The Florida Suncoast Puppet Guild, Inc. shall be a not-for-profit organization formed for educational purposes within the meaning of section 501 (C) (3).
