We the undersigned, for and in behalf of the members of this Organization who duly organized this body as a church, do hereby adopt the following articles of Incorporation under and by virtue of the laws of the state of Florida relative to non profit corporations.

Article 1

The name of this corporation shall be:

Article 4

The general purpose for which this corporation is formed shall be:

1. To preach the Gospel, to administer the ordinances of the new Testament, to minister to the spiritual needs of its members and all people everywhere, to train christian workers for the Lord's work, and to further the evangelization of the world by helping, men, women, and children know Christ as their personal Lord and Savior.

2. To take, secure, accept, hold or acquire by gift, purchase, legacy or otherwise, real and personal property to expedite in the work and purpose for which this body was organized and to hold, lease, incumber, give, exchange or sell and dispose of the same in part or in whole, when it deems such action necessary in promoting and advancing the work and purposes for which this corporation is formed. all such acts to conform to the laws of the state of Florida.

Article 6

This corporation is formed, organized and operated exclusively for charitable, educational and religious purposes as shall qualify as an exempt organization under section 501 (c) of the Internal Revenue code or any future codes relating to charitable organizations.

Article 7

The period of duration of this corporation shall be perpetual.

Article 8

The government of this Church is vested in the body of members who compose it. Thus the final authority for decisions shall be the congregation to whom the church board and staff are responsible.

Article 9

Amendments may be adopted to the constitution or bylaws at any annual meeting of the church by 75% majority vote of eligible members present, provided proper notice embodying such amendments has been presented, discussed, and adopted by a majority vote at a previous regular business meeting.

Article 10

A quorum shall be established when 25% of acting voting age members are present.

Article 11

The registered agent and registered office of this corporation shall be and shall remain until replaced by a majority vote of members.
