**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

Article I: Name

The name of the corporation shall be: The Bisexual Foundation, Inc.

Article II: Principal Office

The principal place of business and mailing address of the corporation shall be:

6700 SW 52nd Street, Miami, FL 33155.

Article III: Purpose

The purposes for which The Bisexual Foundation, Inc. is organized are exclusively charitable, educational, social & cultural in accordance with section 501(c)(3) of the Internal Revenue Code or any corresponding provision of any future Internal Revenue legislation. The corporation is organized for the specific purpose of addressing discrimination against bisexuals, and the socio-cultural isolation of bisexuals and other sexual minorities.

Specifically, the corporation is organized to work towards the elimination of prejudice and discrimination on the basis of gender and sexual orientation; to produce forums, panels, discussion groups and to carry out other educational, instructional and training activities, as well as producing social and cultural events; and to carry out any and all other lawful business.

Article IV: Election of Directors

New directors shall be elected by a majority vote of the existing directors in accordance with the bylaws of the corporation. The six original board members are:

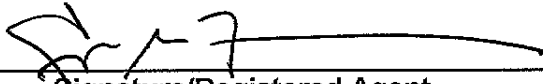

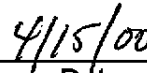
