ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

Next Level Youth of America, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized:

The purpose of the Next Level Youth of America, Inc. is to train, develop and prepare elementary, middle and high school students academically and athletically through the means of physical fitness (track & field), tutorial programs, community service, mentoring program, , drug and alcohol prevention program, clinics, college visits and Jr. Olympic Developmental Program.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

Appointment shall be the manner in which directors and support staff are selected.

- The office of Vice-President shall be appointed by the President,
- the directors of developmental services and activities shall be appointed by the President and/or the Vice President,
- *all staff and coordinators shall be appointed by the executive board.
*note: the executive board shall consist of the President, Vice-President, the director of developmental services and activities.
- Members of the executive committee shall be appointed by the President.
**note: in the event the President office becomes vacant the Vice-President shall become President or shall advise the executive committee to select a President. Vacancies in the other executive positions shall be appointed by the President or a special committee appointed by the President.
