Articles of Incorporation Of

The Lee Island Coast Lighthouse for the Blind INC.

The undersigned acts as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of said not-for-profit corporation

Article I

The name of the corporation shall be <u>The Lee Island Coast Lighthouse for the Blind</u>. The principal place of business of this corporation shall be <u>1916 Van Loon Terrace</u>, S.E., Cape Coral, Florida 33990.

Article II

The period of duration of this corporation is perpetual unless dissolved according to law.

Article III

The purpose for which this corporation is organized is to promote the independence of individuals with substantial vision losses in achieving personal and vocational goals through programs of rehabilitation, education, and adjustment counseling and other related matters and any and all lawful purposes.

Article IV

Qualifications for members and the manner of their admissions are

(1) an interest in the welfare of people who have significant vision impairments and the conditions leading to vision impairments

Article VIII

Article IX

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors.

Article X

The corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law.

Article XI

Article XII

As unanimously voted by the initial Board of Directors, the original officers and directors of this corporation shall serve with compensation for services performed until a Board of Directors can be formed and a staff can be employed to carry out the purposes of the organization.


Article XIII
