ARTICLES OF INCORPORATION OF SUMTER COUNTY SCHOOL READINESS COALITION, INC. (A Florida Not For Profit Corporation)

(A Florida Not For Profit Corporation)

The undersigned, for the purpose of forming a corporation for charitable and philanthropic purposes under Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation:

The name of this corporation shall be: Article 1 - Name:

Sumter County School Readiness Coalition, Inc.

Article II - Term of Existence:

This corporation shall exist perpetually.

Article III - Purpose:

This corporation is formed exclusively as a civic organization for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as that section may from time to time be amended, and, to that end, to do the following:

- To develop and implement a School Readiness Plan within the statutes, rules, regulations and guidelines set forth by appropriate agencies of the State of Florida.
- b. To accept, hold, invest, reinvest and administer income, funds, and property of any sort, without limitation as to amount or value, and to use, disburse, or donate the income or principal thereof exclusively for the charitable purposes otherwise stated in these Articles.
- To the extent permitted by law to exercise its rights, power and privileges, to hold meetings of its board of Directors, to have one or more officers and to keep the books of the corporation.

d. To do any and all lawful acts and things, alone or in cooperation with other persons or organizations, which may be necessary, useful, suitable or proper for the furtherance, accomplishment, or attainment of any or all of the purposes or powers of the corporation.

Article IV - Membership:

The members of this Corporation shall be the Members identified in Exhibit A, attached hereto and incorporated herein by reference, and such other persons as, from time to time hereafter, may be invited to become members, upon the qualifications and in the manner as provided in the Corporation's By-laws.

Article V - Registered Office and Registered Agent

Article VI - Board of Directors

Section 1. The business affairs of this corporation shall be managed by its Board of Directors. This corporation shall initially have twenty-four (24) Directors, whose names and addresses are set forth on Exhibit B, attached hereto and incorporated herein by reference

Section 2. The term of service of each of the initial directors shall commence on the date of incorporation of the Sumter County School Readiness Coalition, Inc. and shall continue until his or her successor shall qualify and take office.

Section 3. The number of Directors and terms of office of additional Directors may be changed at any time and from time to time, by amendment to the By-laws, but there shall never be less than three (3) Directors.

Section 4. Additional Directors shall be elected pursuant to the Bylaws of the Corporation.

Article VIII - Use of Income:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any member, officer, Director, or other private individual (except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, to make payments and distributions in furtherance of the corporation and reimburse individuals for reasonable expenses incurred for the benefit of the corporation), and no member, Director, officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

Article IX - Prohibited Activities:

Notwithstanding any other provision in these Articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986.

Upon dissolution of this corporation, all of its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding Section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose, and none of the assets will be

distributed to any member, officer, or Trustee of this corporation.
