
Dear Mrs. Williams:

Our Administrative Assistant, Lois McLaughlin, called and spoke with you on the morning of November 5, 2001, in regard to the corporation of Sumter County School Readiness Coalition. A letter was mailed to the Department of State on November 5, 2001, dated November 2, 2001. As a result of speaking with you, however, clarification was received as to the options that we have as a non-profit organization. It was stated that notification had been sent to us in January 2001 and again in July 2001, however, not either of the notices in question were received by the Coalition or any of its individual members, to our knowledge. Furthermore, not either of the two previous Coalition Chairs have acknowledged that any such notices were received in any form. The only notice of which the Coalition is aware is the one that was received in the form of Administrative Dissolution or Revocation, stating that action was taken on September 21, 2001, to resolve our corporation.

Because we are not aware of any prior notices, it is our understanding that we would only need to mail a completed reinstatement application along with a check in the amount of \$61.25. It is also our understanding that a letter without the application for reinstatement would not be acceptable or necessary.
