The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is "FLY-BY KNIGHTS" EXPERIMENTAL AIRCRAFT ASSOCIATION (EAA) CHAPTER 1302, INCORPORATED, (hereinafter, "Corporation).
