Name

The name of this corporation is The Faith Life Center Inc. The principal address of this corporation will be 805 Colyer St Orlando Fl 32805.

Article 2

Duration

This corporation shall have perpetual existence being on the date of filing of the articles of incorporation with the state of Florida Department of State.

Purpose
