The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

The name of this association shall be:

ARTICLE II: PRINCIPLE PLACE OF BUSINESS & MAILING ADDRESS

ARTICLE III: PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

To form a unique training program for aspiring actors, singers, and dancers. Students are guided through a rigorous conservatory-style-training program by the resident repertory company of non-union professional actors, dancers, directors, and voice teachers. RAINBOW REPERTORY COMPANY, THEATRE & ACADEMY (RRCT & A) seeks to explore and present a wide range of theater experience for the enrichment and enjoyment of an ever-expanding and diversified audience while it simultaneously provides an environment for training the theater artists of the future.

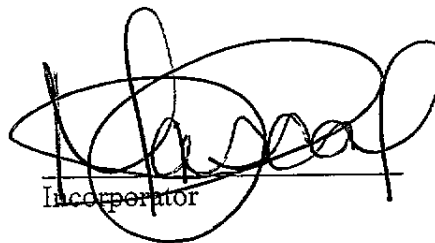
