- ONE: The name of the corporation is E. Jackson ministries, inc.
The address for the principle office is 1406 Oak Street, Palatka Florida, 32177. The organization is organized pursuant to the Florida Nonprofit Corporation Code.
- TWO: This corporation is a religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-Profit Religious Benefit Corporation Law, to establish structured Support service for Evangelistic, Economic Development and other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the corporation creed/bylaws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic Development programs, but shall not be limited to: Homelessness, Health Care, Child Care, Youth at High Risk, Tutorial, Land Acquisition, Housing, job Training, Counseling, Employment and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.


