[Name]: The name of this corporation is THE COCONUT GROVE CHURCH OF GOD OF PROPHECY, INC.  
a corporation not-for-profit.

ARTICLE II

[Duration]: This corporation shall have perpetual existence commencing  
on the date of this filing of these Articles of Incorporation with the  
Department of State.

ARTICLE III

[Purpose]: The purpose of this corporation is to foster Christian  
morals and provide a place of worship for the community.

ARTICLE IV

[Qualification of Members]: Persons indicating a desire to be part of  
this organization, and demonstrating an ability to contribute to the purposes  
of this organization, and receiving a simple majority approval of the board  
will then be made a part of the general membership.

ARTICLE V.

ARTICLE VIII

[Board of Directors]: The Board of Directors shall be elected by the existing Board of Directors.

ARTICLE IX

[Legal Affairs of Corporation]: The legal affairs of the corporation shall be managed by the officers who shall be elected at the annual meeting each year to serve for the ensuing year. The officers of the corporation shall serve until their respective successors in office shall be elected and duly qualified.

ARTICLE X

[Revenue]: No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. The corporation shall not in any way, directly or indirectly, carry on propaganda or otherwise attempt to influence legislation, or participate or intervene in any political campaign on behalf of any candidate for public office, by publishing or distributing statements or otherwise. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to

which are deductible under corresponding provision of any further United State Revenue Law).

ARTICLE XI

[Dissolution]: Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the disposal of all of the liabilities of the corporation, for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

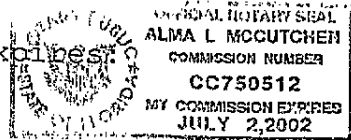
