**ARTICLES OF INCORPORATION  
OF  
THE ROCK CENTER, INC.**

A Non-Profit Corporation

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I  
Name**

The name of the Corporation is The Rock Center, Inc.

**ARTICLE II  
Duration**

The term of existence of the Corporation is perpetual and the corporate existence will commence on the filing of these articles by the Department of State.

**ARTICLE III  
Purpose**

The Corporation is organized for purposes not for pecuniary profit. The Corporation will provide a ministry to youth and families focused on education, training and motivation.

**ARTICLE IV**  
**Registered Office**

The street address of the initial registered office of the Corporation is 4388 Real Court, Orlando, FL 32808. The registered office and the principal address of the Corporation are the same. The name of the initial Registered Agent at such address is Nelson Stone.

**ARTICLE V**  
**Directors**

The method of election of the directors shall be as stated in the bylaws.

**ARTICLE VI**  
**Incorporators**

The name and address of the incorporator is:

**ARTICLE IX**  
**Dissolution**

Upon the dissolution of the Corporation, assets shall be distributed for the exempt purpose(s), for which the corporation was formed, within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose which corresponds to the corporation's exempt purpose(s). Any such asset not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such exempt purpose(s) and to such charitable organization or organizations as are likely to utilize the remaining assets for said exempt purpose(s).

**ARTICLE X**  
**Miscellaneous**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III. No substantial part of the

activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal taxation under 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


