ARTICLE I NAME

The name of the corporation shall be Concerned Homeowners in Partnership, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business shall be 6114 SW 104th Street, Ocala, Florida 34476, and the mailing address shall be PO Box 76142, Ocala, Florida 34481.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to safeguard homeowners rights in deed restricted communities.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected will be by general election of members of the corporation, as set forth in the bylaws of this corporation.

ARTICLE V INITIAL DIRECTORS/OFFICERS

The corporation shall be governed by a board of directors in its day to day business, as set forth in the bylaws. Initial directors and officers will be elected by members of the corporation in an organizational meeting by majority vote. These directors shall be a minimum of five (5) and a maximum of nineteen (19).

ARTICLE VI MEMBERSHIP

The corporation shall have one class of members and no more than one membership may be held by any one person. The rights and privileges of all members shall be equal. Each member shall be entitled to one vote.




